<p><b>Total Crime</b></p> <p><b>Report:</b> Crime &amp; Disorder Victimisation Community Safety Perceptions</p>	<p>-</p>	<p>The level of total recorded crime in Melton Borough has remained stable in 2008/09 compared to the previous year and the previous five year average with only a 3% increase.</p> <p><b>Compared to Leicestershire</b> total recorded crime in Melton follows the same trend as the County with no change from last year or the previous 5 years.</p> <p>The total number of recorded offences in Melton Borough in the first five months of 2009/10 is slighter lower than in the previous year to date.</p>	<p>Melton Borough has a total crime rate per 1,000 population at a similar level to the County as a whole, but is considerably higher compared to both the Force area and nationally.</p> <p>Compared to similar areas Melton Borough has a total crime rate in the bottom (worst) 25% of all similar areas within its group.</p>	<p>There is only 1 area out of the 11 areas of the county with a significantly high volume of crime, within Melton Borough (Melton Craven West).</p> <p>Other areas to consider which sit in the top 25% of areas with high crime are Melton Sysonby South and Melton Warwick West. However Melton Sysonby South has had a significantly lower number of total recorded offences compared to last year.</p>	<p>One-in-five (22%) of Melton respondents are to some degree dissatisfied with the current level of crime in their area. These individuals have been segmented according to whether they prioritise crime as important or not:</p> <p><b>Crime is a priority and needs improving</b> accounts for 12% of Melton respondents. These respondents are more likely to have been subjected to ASB, be poorly informed, live in areas of low social capital, feel vulnerable and have a wish to protect their own personal investments.</p> <p><b>Crime is not a priority but needs improving</b> accounts for 10% of Melton respondents. These respondents are more likely to have been subjected to ASB, live in areas of low social capital, feel vulnerable and live in high crime areas. They are also more likely to suffer from poor health and / or unemployment and rent rather than own their home. Therefore there is a sense that these individuals do not prioritise crime because they have more personal and urgent issues to deal with.</p>	<p>The profile of police recorded Total Crime victims, regardless of the district in which they are resident, are more likely to have the following characteristics:</p> <p><b>Male.</b> Males account for 50% of the County population but 56% of known victims.</p> <p><b>Aged between 18 to 44.</b> Residents aged between 18 and 44 constitute 38% of the county population, yet 57% of known victims.</p> <p><b>Living in OAC Typical Traits.</b> Residents in Typical Trait areas comprise 18% of the county population yet 25% of known victims.</p> <p><b>Living in Output Area Classification (OAC) Blue Collar.</b> Residents of Blue Collar Communities account for 12% of the county population yet 16% of known victims.</p> <p><b>Living in OAC Constrained by Circumstances.</b> Residents of Constrained by Circumstances communities represent 4% of the county population yet 8% of victims.</p> <p><b>Living in OAC City Living.</b> Residents of City Living make up just 1% of the county population, they account for 4% of victims.</p> <p><b>Living in OAC Multicultural.</b> Multicultural residents only account for 1% of the county population, but they constitute 5% of known victims.</p>
