
Public Consultation Results

Q1: In what role are you responding to this consultation?



Respondents were asked to what extent they agreed or disagreed that the purpose of the PNA was clearly explained in the draft. The majority said they agreed (89%), and no respondent disagreed.

Q3: To what extent do you agree or disagree that the purpose of the PNA is clearly explained in the draft?






Respondents were then asked 'Why do you say this?' Five respondents said they felt the information included in the draft PNA was clear.

Current provision

Respondents were asked to what extent they agreed or disagreed that the draft PNA adequately reflects the current community pharmacy provision in Rutland. The vast majority said they agreed (75%), and no respondent disagreed.

Q5: Are there any pharmaceutical services currently provided in Rutland that have not been highlighted within the draft PNA?



Population needs

Respondents were asked to what extent they agreed or disagreed that the needs of the population of Rutland have been adequately reflected in the draft PNA. The majority said they agreed (89%), whereas one respondent disagreed.

Q6: To what extent do you agree or disagree that the needs of the population of Rutland have been adequately reflected in the draft PNA?



Respondents were then asked 'Why do you say this?' Two respondents said the current provision met the needs of the population. Two respondents said the draft PNA and pharmacy provision must focus on the elderly, and two said it must focus on the increasing population. The respondent of who said 'Tend to disagree' specified the proposed development at St Georges Barracks, which could increase the population significantly.



Respondents were asked whether there are any gaps or issues in pharmaceutical provision in Rutland that have not been reflected in the draft PNA. Two said 'Yes', and one said 'No'.

Respondents were then asked 'If yes, what are these?' One respondent said the draft PNA and pharmacy provision must focus on the potential increase of the population due to the proposed development at St Georges Barracks, and one said the PNA should reflect on the provision of extended hours.

Recommendations

Respondents were asked to what extent they agreed or disagreed with the recommendations in the draft PNA. The majority said they agreed (75%), and no respondent disagreed.

Respondents were then asked 'Why do you say this?' Three respondents said the draft PNA covered the needs of the population well. However one respondent said the draft PNA and pharmacy provision must improve provision for end of life care, the rurally isolated population and provide Out of Hours services to reduce travel times. One respondent said merging pharmacies may be difficult.

Respondents who indicated that they were responding in a professional capacity were then asked what, if anything, they or their organisation could do to take the recommendations forward. Two respondents said they could communicate with other providers, and one said they could provide a wider range of services.


Respondents were asked whether they had any other comments. One respondent said the draft PNA met the needs of the population, and one said they worked with Rutland County Council.
